2. Approval of Minutes

4. Old Business

i. Vineland Developmental Center West Campus

Sandra Forosisky advised the State sent the contract for the sale of property, the mayor signed, and it is now at State level. The SHPO memorandum of understanding for historical significance will be clear. State is maintaining ownership of school. Concerns with 3-million dollars in grant funding has been discussed with Triad and they have advised funds were already allocated so this would not be an issue. Dan Kuhar requested an estimated time frame, Sandy advised if all work stays the course lots would be available in about a year. Price per acre will be determined once all site and environmental work is completed. As progress is made members will be updated.

ii. Weymouth Road

Sandra Forosisky advised Road Ray Cronk was given contract for property located south side of Weymouth. Once contract is signed Alan will provide Dan with contract for signature. As updates are made members will be updated.

Sandy also provided an update on North side of Weymouth Road; two lots have been acquired from Malaga Campground. All owners may require a variance to maintain residential/farm area. Long term the commission would like to work with DEP regarding the sewer service/availability at the refenced lots. The sewer service area is approved by DEP and Weymouth Road is currently environmentally protected. As progress is made members will be updated.

5. Other Business

Members discussed property located at the intersection of Grove Lane and Carol Drive, the commission agreed the lot could be subdivided into two lots for smaller users. One lot would front Forest Grove, Sandy added all lots are now in the UEZ. Members also discussed property located at the intersection of Forest Grove and Grove Lane, we are currently working on water utility connection to make the land more marketable. There is sewer available at the Blvd that could tie into these lots.

Dan Kuhar asked if there is anything pending for the intersection of Demarco Drive and Garden Road. Sandy advised she will talk to DJ and provide updates.

Sandy advised the UEZ has expanded and includes additional industrial lots, we will be sending letters to all businesses to let them know they are now located in the UEZ and are eligible for UEZ benefits.

Dan Kuhar asked about lighting and landscaping around the industrial areas and Industrial Park. Sandy advised we currently have a contract with Turf Construction for landscape and irrigation maintenance at the industrial park signs, Sandy added she will talk to engineering to discuss landscape and lighting in other industrial areas and provide update.
