- a. Background Check Updates for Current and Active Coaches & Volunteers:
All leagues need to submit their current coaches, volunteers to Recreation Office
Emails have been sent to league presidents for names, DOB and phone numbers of all volunteers. Most leagues have complied.
List of approve coaches and volunteers are being submitted to T & F Camera for processing of I.D Badges weekly with contact numbers for T & F to set up appointments.
- b. Report on League Updates - A request has been submitted to change Mill & Walnut Little League field to a 50/70 field. EVLL NVLL have a shorten season. SVLL cancelled
- c. Perfect; Game Did not use any fields this summer
- d. Travel Baseball teams have been granted limited field use at Landis Park-Romano Baseball & EVLL fields. Softball travel teams used Vineland Pigtail fields. NO MIDGET FOOTBALL PROGRAMS this fall. Limited soccer this fall for VSA.
- e. Facilities Maintenance Updates:
City of Vineland Recreation has been remediating the (green) field storage boxes at most field location. (9) boxes are completed. An extra storage box was provided to VBA. New Slide at Pagliughi playground installed. New netting at Romano Soccer field 6
New Netting at Fiocchi field #1 concession stand area. New fencing at Pagliughi Park along basketball courts. All old netting and cables removed from Third Street baseball and new dugouts built at Romano Baseball. New outside stairway built at field #1 Cunningham Park. Field #2 will have demo of press box and new roof for dugout.
Facilities Usage:
Fields were scheduled to open June 22nd practice only baseball. Games July 6th-August. Special rules for coaches social distancing, parents must sit in outfields, no more than four kids in a dugouts. Temperature must be taken of each athlete before going on the field and recorded by coach(s). Romano Soccer Field #5 has a new irrigation system,
