- -Chris from the Vineland Midget Football League would like to dedicate the 3rd St Basketball Courts in honor of the passing of Mr. Harvard. He was a 38 plus year veteran teacher/coach in the community. The Commission mentioned going bigger and naming the High School Gymnasium after him and suggested he speak to the BOE. If that doesn't work out, we will dedicate the 3rd St Basketball Courts in his honor.
- -Gabe Santiago of Clutch Baseball would like to propose using Magnolia field and the field at Mill and Walnut for his practices and training. Mr. Clay mentioned that he is in contact with Rowan University in regards to our Lifeguard issue. He is also looking into having the instructors give free lessons to kids who can't swim in the morning before the pool opens up to everyone.
