It is the responsibility of the Owner and/or Creditor to ensure that the City of Vineland has the most current and up to date information. If you do not have access to all of the information requested on this form, you <u>MUST</u> retrieve this information from the correct party before submitting this form. Incomplete and/or Incorrect information will result in a Notice of Violation being issued.

- *THE VACANT REGISTRATION FORM MUST BE COMPLETED IN ITS ENTIRETY AND SUBMITTED WITHIN 30 DAYS AFTER THE BUILDING BECOMES VACANT PROPERTY OR WITHIN 30 DAYS AFTER ASSUMING OWNERSHIP OF THE VACANT PROPERTY, WHICHEVER IS LATER.
- * THE VACANT REGISTRATION FORM MUST BE SUBMITTED WITH A CHECK PAYABLE TO THE CITY OF VINELAND, A COMPLETED VACANT/FORECLOSURE WORKSHEET AND A COPY OF THE CURRENT LETTER OF INTENT.
- *REGISTRATIONS MUST BE RENEWED ANNUALLY UNTIL THE PROPERTY NO LONGER MEETS THE DEFINITION WHICH REQUIRED THE REGISTRATION.
- *THE REGISTRATION DATE IS THE DATE THE PROPERTY MET THE DEFINITION OF VACANT, ABANDONED OR NUISANCE, WHICHEVER COMES FIRST.

Chapter 530-14, Section A: Any owner or creditor who is not in full compliance with this chapter, or otherwise violates any provisions of this chapter, shall be subject to a fine of \$1,500 for each day the violation continues. Fines assessed under this chapter shall be recoverable from the owner or creditor, as the case may be, and shall be a lien on the property.

Chapter 530-14, Section D: For purposes of this section, failure to file a registration statement in time, failure to provide current and correct information on the registration statement, and failure to comply with the provisions of any portion of this chapter shall be deemed to be violations of this chapter.
