NJ PLANNING COMMISSION PUBLIC HEARINGS



The New Jersey State Planning Commission will be conducting six public hearings for the purpose of receiving testimony on the draft Final New Jersey's State Development and Redevelopment Plan, and the draft Infrastructure Needs Assessment pursuant to the State Planning Act as set forth in the State Planning Rules.

There will be a combination of six (6) virtual and in-person hearings. Virtual Hearings are scheduled for October 14 and 16 at 6:00 pm, and October 15 and 17 at 9:00 am. In-person hearings are scheduled for October 14 at 9:30 am in the Burlington County Library Auditorium, and October 15 at 6:00 pm at the Morris County Public Safety Training Academy.

The public may comment at the hearings or may submit written comments to the Office for Planning Advocacy at any time up to 30 days after the last public hearing is conducted. IMPORTANT DATES FOR THE NOVEMBER 4 ELECTION

Election day for governor, state, and county offices is Tuesday, November 4 with polls open from 6:00 am to 8:00 pm. If you are not currently registered, the registration deadline is October 14.

This year's early in-person voting period will begin on October 25 and run through November 2. In Vineland, you will be able to vote early at the Vineland Fire Department Station No. 6 located at 400 W. Plum Street, Monday-Saturday from 10:00 am to 8:00 pm, and Sunday 10:00 am to 6:00 pm.

If you would like to vote by mail, the deadline to apply by mail is October 28. The deadline for In-Person Mail-In Ballot Applications is November 3. If you would like to drop off your completed ballot at a secure Drop Box by November 4, they are located at the Cumberland County Technical Education Center at 3400 College Dr., Vineland City Hall at 640 E. Wood St., and the Cumberland County Division of Social Services at 275 N. Delsea Dr. The deadline for Post Office receipt of Mail-In Ballots is November 4.
