**Temporary signs are subject to the following provisions:**

- (a) The message carried on a temporary sign shall pertain to and be limited to the business conducted on the premises.
- (b) A property shall only display a single temporary sign at any one (1) time.
- (c) A property shall be limited to sixty (60) days per calendar year for a temporary sign, irrespective of the number of businesses or tenants located on the property.
- (d) It shall be the responsibility of the owner of a property with multiple tenants to determine which tenant or tenants may utilize temporary signs and for what duration.
- (e) Maximum size permitted: 32 sq. ft.
- (f) Maximum height permitted: 6'
- (g) Sign must be located a minimum of 10' back from the front property line(s) and a minimum of 20' from side property lines.
- (h) Separate applications/zoning permits are required for non-consecutive days
- (i) Flashing and/or "moving" lights are prohibited
- (j) Sign copy may not change more than eight times per day.
